# **Biographical Information**

Two Quaker families, the Bowermans and Giffords of West Falmouth, were united by the marriage of Virtue Russell Bowerman (1875-1963) to Arnold Joseph Gifford (1868-1939) in 1907.

William Gifford (1615-1687) first settled in the West Falmouth area when he purchased forty acres of land from an Indian, Job Attukkoo, in 1673. Over the course of 300 years, the Bowermans and Giffords were farmers, dairymen, teachers, and devout members of the West Falmouth Society of Friends.

# Scope and Content Note

The Bowerman-Gifford family papers, dating from about 1670 to 1976, reflect the activities of members of these two families and persons related to them by marriage. Included in the collection are personal correspondence; marriage certificates; property deeds; farm, estate, and other business records; school reports; writings by West Falmouth residents; illustrations; and photographs of family members, friends, and early West Falmouth scenes. Among the personal papers are biographical and genealogical data as well as diaries and other books, including family Bibles.

Of note are a deed in which William Gifford purchases forty acres of land in the West Falmouth area from an Indian, Job Attukkoo (1673); a document related to the manumission of "Cofe the Negro" (c. 1735); a

# Administrative Information

# **Custodial History**

The custodial history of the collection is undocumented. However, it is supposed that Virtue Bowerman Gifford collected and identified most of the material in the 1950s; some of the materials were collected and displayed by Arnold B. Gifford during the 1960s when the Bowerman House was opened to the public as the Saconesset Homestead.

# **Acquisitions Information**

Materials were collected by members of the Bowerman-Gifford family and donated to the Library in multiple acquisitions (acc. 2016-03). The bulk of the materials were donated by Dorothea Gifford in March 1994, although this transaction is undocumented.

# **Processing Information**

When the collection was donated to the Library in 1994, Harriet B. Quimby and Charlotte Price identified and arranged much of the material. The collection was then processed by William and Shirley Dunkle from about 1995 to 1996. The Dunkles encapsulated many of the original documents and prepared an index of the collection.

Reprocessed and finding aid created by Katy Sternberger from August to November 2016. Oversize materials originally from box 16 were placed in the flat file. Framed copies and transcriptions of documents, originally in box 17 and now located in box 18, were removed from the frames for preservation reasons. Fragile glass plates and slides, still in their original boxes, were rehoused in proper four-flap enclosures and storage boxes; these photographs, originally located in box 30, are now located in box FR01 and box FR02, designated for fragile material.
